## Parental Consent Withdrawal

Please read the following carefully before completing the form.

As a Federation we have contractual, statutory and/or regulatory reasons why we process and hold details of a pupil, staff member, volunteer and other person.

Where two parents share Parental Responsibility, or where Parental Responsibility is shared and the pupil is capable of expressing a view and there is conflict between the individuals, the process of withdrawing consent will be subject to an evaluation and discussion to enable a decision to be reached that is considered to be in the pupil's best interests.

We may need to seek identification evidence and have sight of any Court Order of Parental Responsibility Agreement in some cases to action this request. If this is the case, a senior member of school staff will discuss this with you.
